

GOODFOOD - "THE GOLDEN TICKETS" - RULES AND REGULATIONS

- 1. Eligibility: The Contest is only open to legal residents of Quebec, Ontario, Manitoba, Saskatchewan, Alberta, British Columbia, New Brunswick, Nova Scotia, and Prince Edward Island. Employees of Goodfood, its affiliates, subsidiaries, advertising and Contest agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the Contest. No purchase is necessary to enter or win the contest. A purchase does not increase the chances of winning.
- 2. Agreement to Rules: By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. In addition, You agree to accept the decisions of Goodfood as final and binding as it relates to the content of this Contest.
- 3. Contest Period: Entries will be accepted starting on July 16th, 2018 at 12:01AM eastern standard time (EST) and ending August 11th, 2018 at 11:59PM (EST).
- 4. How to Enter: All clients expecting a Goodfood delivery between July 22nd and August 18th are automatically eligible to win a prize. You can also send your spontaneous entry by email at chef@makegoodfood.ca with your full name, full postal address, phone number and email address. Only 1 participation per household per prize is accepted. One may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of Goodfood.

5. Prizes:

Between July 22nd and July 28th, 40 prizes will be distributed:

2x Prize A: 1 free month of Goodfood boxes for a value of up to \$724 maximum; (1 box will be delivered to the Winner per week, for 4 consecutive weeks, on either Sundays, Mondays, Tuesdays, Wednesdays, Thursdays or Fridays depending on the Winner's choice and carriers' availability), retail value of the prize, depending on the Winner's plan and servings choice, will range between \$236 to \$724; 18x Prize B: 1 free Goodfood box for a value of up to \$87 maximum each, retail value of the prize,

depending on the Winner's plan and servings choice, will range between \$59 to \$87); 20x Prize C: 1 free Goodfood binder of a value of \$5 each.

Between July 29th and August 4th, 40 prizes will be distributed:

2x Prize D: 2 free months of Goodfood boxes for a value of up to \$1,448 maximum; (1 box will be delivered to the Winner per week, for 8 consecutive weeks, on either Sundays, Mondays, Tuesdays, Wednesdays, Thursdays or Fridays depending on the Winner's choice and carriers' availability), retail value of the prize, depending on the Winner's plan and servings choice, will range between \$472 to \$1,448; 18x Prize B: 1 free Goodfood box for a value of up to \$87 maximum each, retail value of the prize, depending on the Winner's plan and servings choice, will range between \$59 to \$87); 20x Prize C: 1 free Goodfood binder of a value of \$5 each.

Between August 5th and August 11th, 40 prizes will be distributed:

2x Prize E: 3 free months of Goodfood boxes for a value of up to \$2,353 maximum; (1 box will be delivered to the Winner per week, for 13 consecutive weeks, on either Sundays, Mondays, Tuesdays, Wednesdays, Thursdays or Fridays depending on the Winner's choice and carriers' availability), retail value of the prize, depending on the Winner's plan and servings choice, will range between \$708 to \$2,353; 18x Prize B: 1 free Goodfood box for a value of up to \$87 maximum each, retail value of the prize, depending on the Winner's plan and servings choice, will range between \$59 to \$87); 20x Prize C: 1 free Goodfood binder of a value of \$5 each.

Between August 12th and August 18th, 40 prizes will be distributed:

2x Prize F: 6 free months of Goodfood boxes for a value of up to \$4,706 maximum; (1 box will be delivered to the Winner per week, for 26 consecutive weeks, on either Sundays, Mondays, Tuesdays, Wednesdays, Thursdays or Fridays depending on the Winner's choice and carriers' availability), retail value of the prize, depending on the Winner's plan and servings choice, will range between \$1,416 to \$4,706; 18x Prize B: 1 free Goodfood box for a value of up to \$87 maximum each; retail value of the prize, depending on the Winner's plan and servings choice, will range between \$59 to \$87); 20x Prize C: 1 free Goodfood binder of a value of \$5 each.

Winners will be notified by email or by addressed mail within 10 days following selection. Goodfood shall have no liability for Winner's failure to receive notices due to spam, junk e-mail or other security settings or for Winner's provision of incorrect or otherwise non-functioning contact information. If Winner cannot be contacted, is ineligible, fails to claim the prize within two (2) days from the time award notification was sent, or fails to timely return a completed and executed declaration and release as required, the prize may be forfeited and an alternate Winner selected. Receipt by Winner of the prize offered in this Contest is conditioned upon compliance with any and all federal, state, and local laws and regulations. Terms & Conditions: Goodfood reserves the right, in its sole discretion, to cancel, terminate, modify or suspend the Contest should virus, bug, non-authorized human intervention, fraud, or other cause beyond Goodfood's control corrupt or affect the administration, security, fairness, or proper conduct of the Contest. Goodfood reserves the right, in its sole discretion, to disgualify any individual who tampers or attempts to tamper with the entry
